This communication sets forth reportable action, if any, of the Board of Directors ("Board") of the Fresno County Fire Protection District ("District") consistent with provisions of the Ralph M. Brown Opening Meeting Act (Government Code Section 54950, *et seq.*) resulting from the Closed Session of the October 7, 2020 Skype Virtual Special Board Meeting, noticed consistent with Governor Newsome's Executive Order N-29-20 under the provisions of Government Code Section 54957.1.
